

What can you claim if you're a nurse, midwife or direct carer

With work-related expense claims high on the ATO radar, the Australian Taxation Office is stepping up to help and provide advice for taxpayers who aren't quite sure what they can and cannot claim.

The ATO have already flagged that overclaiming of deductions is a big issue. The ATO wants tax payers to get right what they claim as tax deductions. What you can and can't claim

Each occupation has specific circumstances which affect what can and cannot be claimed. Here are some snippets from some ATO occupation guides. Remember, regardless of the occupation you are in, you can only claim the work-related part of expenses, and you must meet the three golden rules:

- You must have spent the money yourself and not been reimbursed;
- The claim must be directly related to earning your income; and
- · You need a record to prove it.

Nurses, midwives and direct carers: work-related expenses

Common deductions include the following:

- · Union and/or professional fees,
- Travel between clients or sites on the same day,
- · The cost and/or laundry of uniform,
- · Work related phone calls,
- Technical or professional publications, and
- The cost of tools and/or equipment you were required to use for work.

However, you cannot claim home to work travel, plain clothes you wear to work (like closed in shoes or black pants), or study that is not directly related to your current job.
